The following parameters will also apply to any club-sponsored tournament, regardless of format. The Club will be reimbursed appropriately for the use of its facilities for all tournaments and other activities and/or events scheduled and managed by this committee. This reimbursement will be reached by an agreement between this committee and the Board of Directors. Golf cart rental fees will be reimbursed to the Club for all events.</p>

The Board of Directors shall employ, supervise, or discharge any lifeguards or other extra help where necessary for the best interest of the swimming facility. This committee will also offer any suggestions to the Board for updating pool rules, operations, etc. Under unusual circumstances the Board may also ask the committee for additional assistance if deemed appropriate.</p>
